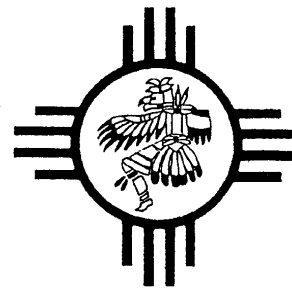

Michael Levy of Tucson, was sitting West and declared the hand in 3NT. North led the ♥2 which was won by South with the ace and he continued with the ♥Q which declarer won performe with the ♥K. He now played the ♠J and let it ride as north followed low and south with ♠9.

Declarer now cashed the ♦A & ♦K and followed with a small spade to the ♠K on which South pitched a low club. At this point the ♥10 was played and South cashed his 3 remaining hearts.

In the four card ending this was the position:

♠ Q8 ♥ --- ♦ Q9 ♣ --- ♠ AT ♥ --- ♦ --- ♣ J9 ♠ --- ♥ --- ♦ --- ♣ KT86	♠ 5 ♥ --- ♦ 8 ♣ AQ

South was forced to lead a club, giving declarer two tricks in that suit and North was squeezed. He must keep the ♦Q to prevent ♦8 becoming a winner so he must bare his ♠Q allowing declarer to cash ♠AJ and make his contract.

This well played hand earned 14 IMPs as at the other table the contract was 4 spades minus two.

Well played Mike!

Editors note: Even if South refuses to cash his 4th & 5th hearts and exits with a club, the contact can always be made by cashing two clubs throwing North in with diamonds to lead spades at the end. Try it and see.

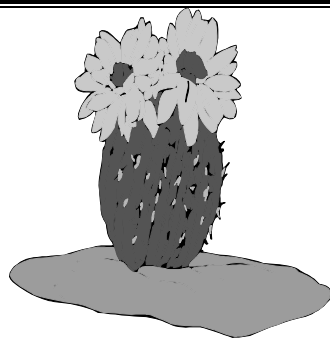
